BENEFITS TO THE RECIPIENT

The goal of Scholarship/Bursary funds is to provide an investment in the recipient's formation and preparation for future opportunities in Christian ministry by:

- Reduce the competing demands generated by the need to invest in study while also raising financial support to cover the payment of fees and living expenses.
- Where helpful and strategic, enable the recipient to complete more units than is necessary for the conferring of the enrolled degree.

CONDITIONS OF RECEIPT

Beneficiaries must be willing to be involved in promotional activities for the scholarship or bursary fund.

Scholarships/Bursaries are normally applied as a discount to enrolment fees but may be paid as a taxable living allowance.

Recipients of a scholarship must advise the Registrar in of any changes in their enrolment status subsequent to being awarded a scholarship—subsequent changes to enrolment may have an effect on the scholarship awarded as detailed below.

Funds available for Scholarships/Bursaries are limited, and are only awarded each semester by this process and decision of the Scholarships Committee — Principal, Vice-Principal, Chief Financial Officer and Registrar.
